IN ORDER TO ENSURE AN ORDERLY PROCESS AND TO IMPACT OUR GUESTS AS LITTLE AS POSSIBLE, arrival and departure dates must be agreed with us in advance (preferably between 9 a.m. and 4 p.m.)

Arrival- and departure-days are charged as full.

It is essential to present the vaccination certificate at every check-in otherwise; we will not be able to welcome your cat.

GENERAL TERMS AND CONDITIONS & ENTRY REQUIREMENTS

(They are integral part of the residence contract)

Vaccinations

All cats must be vaccinated against herpesvirus, panleukopenia and calicivirose (Polyvaccine) and against feline leukemia (FeLV). We also need the FeLV test. The last vaccination must not be older than a year.

Parasite Control

All cats must have been dewormed and treated against external parasites (fleas and ticks). The treatment must not be older than one month. If requested, we can take care of this upon arrival (costs will be billed).

Sterilization

All cats must be spayed / neutered. An exception applies to young animals that have not yet reached sexual maturity.

Cancellations and booking changes

Any cancellation or change to the booking must be communicated to us in writing (by email).

The reservation can be cancelled free of charge up to 3 days (72 hours) before the date of arrival (00:00), unless otherwise agreed. In the event of a later cancellation, the booking amount will be charged, and is due in full.

Invoices

The invoice must be paid in cash or by credit card upon checkout. If the vacation ends prematurely, the days originally booked will be fully charged. Arrival and departure days count as vacation days and will be charged in full.

Important

If the cat falls ill or needs to be quarantined, we are expressly authorized to take all necessary measures that lead to the care and healing of the cat, including obtaining professional support from the in-house veterinarian. The costs incurred will be billed to the owner.

DISCLAIMER

In principle, all responsibility rests with the cat owner. The Aristotel staff is only liable for any willful and grossly negligent behavior on their part. Any further liability, in particular in the event of accidents, illnesses or deaths, is excluded.

Place of jurisdiction and applicable law

In the event of disputes, Swiss law is exclusively applicable. The competent place of jurisdiction is the District Court of March, Bahnhofplatz 3, Postfach 48, 8853 Lachen. Only the contract/provisions in German language are legally valid and applicable.
